We will not charge you any interest on purchases if you pay your entire balance by the due date each month. We will begin charging interest on cash advances and balance transfers on the transaction date.

<sup>1</sup>**Variable Rate Information:** Your APR may increase or decrease. Rates are determined and adjusted monthly on the first business day by adding a Margin to the highest U.S. Prime Rate published in the Wall Street Journal on the first day of the previous month. The Margin is determined based on an evaluation of each member’s credit history. The Margin will range from 6.99% to 15.99%.

<sup>2</sup>**Late Payment Fee:** You will be required to pay a late payment fee of \$25 if you do not pay at least the minimum payment by the payment due date on your statement. Carolina Trust Federal Credit Union may also assess the late payment fee every month thereafter that you are past due.
